

Day by day itinerary Day 1 Thursday 6th July 2023 Edgworth to Hexham and Blyth

Pick up from Edgworth followed by Bromley Cross and then make our way to the first port of call, the historic and beautiful market town of Hexham. renowned for its beautiful Grade I listed abbey, which dates back to AD674, though developed into its current form in the 12th century. The beautiful Abbey Grounds and adjacent Sele Park are a lovely place for a stroll. Plenty of time will be allowed here to visit the abbey and enjoy lunch in one of the town's many cafes and pubs. After lunch, our first included visit is to the historic Dilston Physic Garden, whose collection of medicinal plants will be explained on an hour-long guided tour with additional time to explore independently. Then we head east to the coast and the Commissioner's Inn in the port of Blyth, for dinner and overnight.

Day 2 Friday 7th July 2023 Howick Hall with lunch and **Alnwick Castle**


Two magnificent venues are on the agenda today, the first of which is to Howick Hall, home to Earl Grey (immortalised thanks to his choice of tea), where we will explore the gardens and Arboretum with a guided tour from one of the enthusiastic volunteers. Lunch is included at the Earl Grey Tea House before heading the short distance to one of Northumberland's most iconic sights, Alnwick Castle, made famous throughout the world, thanks to the huge popularity of the Harry Potter films, which were filmed in part here. It dates back to the 11th century, and remains the home of the Duke of Northumberland to this day, and is the second largest inhabited castle in England after Windsor. Its magnificent gardens and renowned poison garden will be explored on a 90 minute guided tour. Return to the hotel for dinner and overnight.


Day 3 Saturday 8th July 2023 Bide-A-Wee Nursery and Garden and **Belsay Castle**

Our first visit today is to Bide-A-Wee Garden, which has been created out of a small sandstone quarry over the last quarter of a century by Mark Robson. The site was originally bare and exposed apart from rough grass, whin (gorse) and an outer drystone boundary wall. It has taken years of imagination, planning, development, hard work and nurturing to transform this former quarry into a garden oasis, described by Gardeners World magazine as "a very special garden" and one of "Your Best 100 Gardens 2019." Here, we'll enjoy a guided tour and tea & biscuits before heading to Belsay Castle (English Heritage) for a light lunch before visiting the spectacular house and gardens, including the unique microclimate of its Quarry Garden filled with exotic plants. Dinner and overnight at the hotel.

Day 4 Sunday 9th July 2023 Whalton Manor, Wallington and return to Edgworth

Alas, it is time to head home today but with two wonderful visits on the way. First of all we visit Whalton Manor Gardens, an historically significant 17th century house with a three-acre garden, bursting with inspirational planting and magnificent architectural structures, such as the charming Lutyens-designed, Italianate summerhouse, game larder, pergolas and vast stone-paved courtyard. From here we head to the National Trust's Wallington, where a historical house meets rolling hills, woodlands and a walled garden, with time for lunch and a visit to the house and gardens before rejoining the coach and heading back to Edgworth with late afternoon arrival.
